

With the goal of providing all members of LGANT, stakeholders and other parties with transparency and knowledge, the annual report provides an extensive overview of LGANT's economic health and performance for the financial year. Additionally, it provides useful information about local government in the Northern Territory, the membership of LGANT, its strategic priorities, and its notable achievements for the year.

This report has been prepared in compliance with clause 22.3 of the LGANT constitution which requires it to be tabled for the members of LGANT at an Annual General Meeting. This meeting will take place on Friday 10 November 2023 at the DoubleTree by Hilton Esplanade Darwin.

## ABOUT **LGANT**

LGANT has a nine-member Board Committee which has overall carriage of the organisation's affairs as detailed in the constitution and governance charter. LGANT's policy statements are regularly updated and reflect the local government sector response to issues.

LGANT is the voice of local government in the Northern Territory. It represents 16 municipal, shire, and regional councils, 63 local authorities, 66 remote communities with a physical council presence and 614 homelands with over 100 Aboriginal languages and dialects. We provide leadership, support, representation, and advocacy on behalf of our member councils for the benefit of their communities. Local government makes a significant contribution to the Northern Territory economy. Collectively, councils employ around 3,000 Territorians, is the largest employer of Indigenous people in remote and regional areas, manages and controls assets and infrastructure valued at \$2.57 billion and is responsible for over 14,000 kilometres of roads.

The sector receives and expends over \$505 million in the Northern Territory annually.

## PRESIDENT'S **STATEMENT**

#### A shout out to those doing their best to make life easier, better and safer in our communities across seventeen percent of the nation.

Thank you to the over 3,000 council employees looking after 14,000 kms of roads and \$2.7 billion in assets. To the elected members, some driving thousands of kilometres in a round trip to attend meetings, the Mayors and President's for whom their role really is a full-time job, the age and child care workers, the Rangers, the accountants, the Executive Assistants, the waste managers, the social workers, the engineers and the Human Resource officers, to you all congratulations on a job well done.

The past twelve months have not been without its challenges, and I remain very proud of our Principal Members, Councillors, CEOs, staff and volunteers for what they achieved.

The Board and I are working very hard for fairer conditions for Principal Members and elected members, including advocating via the Secretariat for superannuation, resettlement allowances, increased allowances for travel to and from meetings and a stronger and fairer Code of Conduct under the Act.

In March we had floods to the north west affecting communities in the Vic Daly region like Kalkarindji, Pigeon Hole and Daguragu causing evacuation and disruption. We need early warning infrastructure installed as a matter of urgency and other options to sending people off country. Local government input needs to be listened to, and that is why we are seeking, on behalf of our councils, full membership of the Territory Emergency Management Council or TEMC, at present we are only Observers.

Fires are still burning in the Barkly so far consuming almost 3 million square kilometres with a 200km front. The Barkly Regional Council has been praised for its fantastic work in keeping locals informed. As with the floods the NT Fire and Emergency Services, did a magnificent job but still we needed assistance from the Australian Defence Force (ADF). LGANT is fighting against a proposal from the Commonwealth Government to limit the deployment of the ADF in times of emergency events. The NT doesn't have the luxury of the aggregation of support from other emergency services that other jurisdictions have so the ADF's support is vital.

In a time of crippling inflation and difficulties in retaining and attracting staff making it more costly and difficult to do council business, you all dug a little deeper. For those we serve the rising costs of living have hit home, made worse in a limited and expensive housing market. Despite all of this your LGANT is working harder than ever to find answers and ensure our sector gets a fair go.

A big part of getting a better deal for Territorians is our joint advocacy with the Australian Local Government Association's (ALGA) for a call on the Federal Government to restore Financial Assistance (FA) Grants to at least one per cent of Commonwealth taxation revenue to address the serious financial sustainability issues experienced by all councils. At present we are only getting 0.5%! We will also be advocating for the abolition of conditional rating so that member councils can charge rates on mining and pastoral activity, if this is not agreed to, we will lobby for an increase to conditional rating so that more of the money generated in our regions stay in our regions and with councils to improve service delivery particularly in the more remote communities.

I very much welcomed the review into Local Authorities that was well handled by the Local Government Unit of the government. It is the start of greater recognition for local leaders making local decisions as they will start to play a greater role in delivering voice to communities.

At the April LGANT General Meeting and Conference we explored financial sustainability, governance and workforce. Out of that came the renewed need for a PR campaign to tell the local government story and inspire people to work for councils by positioning the sector as an employer of choice. LGANT will announce the successful tender in December. LGANT also put out an EOI for a training provider to supply LGANT a range of training options that members can access in the future via a one-stop-portal on our new website.

LGANT has finally transitioned out of the Local Government Act into a Company Limited by Guarantee. This saw a name change from the LGANT Executive to LGANT Board. We welcome Mayor Lis Clark from the Katherine Town Council who is filling a Casual Vacancy. The Annual General Meeting in November last year saw three new faces join us in. Councillor James Woods from the West Arnhem Regional Council, Cyril Tasman from the Central Desert Regional Council and President Sharon Beswick from the Coomalie Community Government Council.



## **CEO'S STATEMENT**

Our vision is for a robust local government sector creating diverse, sustainable and liveable communities across the Northern Territory. In doing this we will go a long way to retaining who we have in our communities and attract the people and skills that we need.

Local government is still largely misunderstood. I believe councils exist primarily to contribute positively to community wellbeing. They do this as part of the third sphere of government, being the local democratically elected representatives while delivering services and infrastructure.

LGANT's job is to make life easier for our member councils through advice, advocacy and public policy development and influence. We are also an information exchange agency. We collect, send, analyse and generate information between councils, the Commonwealth and Territory governments.

LGANT is a staff of seven and a Board of nine. The Board consists of eight member councils which is half of our total membership and includes five regional and shires councils. The Board sets the policy and strategy, and the staff are organised to achieve the outcomes.

On behalf of the Board and the staff it gives me great pleasure to present the 2022-2023 Annual Report.

As required under Section 25 (c) of the LGANT Constitution, this report includes the audited annual financial statements for the 2022-2023 financial year. The financial position and performance of LGANT was sound as of 30 June 2023.

For the next twelve months LGANT will continue its renewal. Already we have a new Constitution, refreshed our logo and rebranded and will launch our new website. We have conducted an external review of our finances and in the new year we will launch our 2024-2027 Business Plan. This will include what new services we will provide for our members, how we will increase own source revenue and lessen the reliance on grants and funding from the Commonwealth and Territory governments.

We will look for change and partner with organisations that have the expertise we don't, we will explore the greater use of technology and ramp up our policy and advocacy work. This forward-looking optimism we will carry over into achieving greater outcomes for communities. In an effort to better communicate and exchange information in real-time we instituted Strategic Priority Working Groups that align with our seven strategic priorities

Perhaps not since 2006 has the spotlight been so bright on Local government. The sector is being challenged to be better, to do more and we are united in doing just that and at its core is greater funding and greater autonomy. There is a lot of chat from outside about the right structure

to deliver representation and services, to create jobs and "give people what they want". All this can be done under the current framework, it's not the political system we should be focussed on as it is only the end product, rather it's about the inputs, it's about more untied grants and real funding to make real decisions to make real difference by locals for locals.

Local government councils are buildings, flagpoles, meetings, 4WDs, meetings, polo shirts with logos, meetings and the seemingly endless pursuit of compliance. But councils are more, much more. They are people. They are everyday people doing everyday things every day. If we include the seventeen local government councils and the Local Authorities, there are 850 democratically elected members for a start who have to make corporate decisions on multi-million dollar budgets, they are people who deeply care about doing things better.

Good luck in retirement to LGANT stalwarts Peter and Maree McLinden, former MacDonnell Regional Council CEO Jeff MacLeod and former LGANT Board member Judy MacFarlane.

Congratulations to the elected members and the 130 council staff across the NT awarded LGANT long service awards. At the other end I would like to sincerely welcome our new CEOs, Andrew Wilsmore (Alice Springs Town Council), Virginya Boon (Wagait Shire Council), Ian Bodill (Barkly Regional Council), Sharon Hillen (Coomalie Community Government Council), Belinda Urquhart (MacDonnell Regional Council), Acting CEO Jessie Schaecken (West Arnhem Regional Council), Gina McPharlin (Tiwi Islands Regional Council) and from the Nhulunbuy Corporation, Shane Whitten.

The LGANT Board and the LGANT Secretariat are working with member councils on over 60 different issues including economic development, roads, housing, connectivity, animal management, gamba grass control, cyclone shelters, emergency management, recruiting, burials and cremations, alcohol management, town camps, homelands funding, planning and airstrips.

Our member councils have been doing some great things including the Central Desert Regional Council winning the Local Government Professionals NT (LGPro NT) Executive Management Challenge and represented the sector at the Nationals in Adelaide. LGPro NT is a partner of LGANT to assist in growing the capacity of our workforce via training and mentorship.

This year LGANT signed a five-year contract with the Department of Environment, Parks and Water Security to roll-out the LGANT Local Government Circular Economy Plan. We have employed Meredith Newall as the Plan's program officer and during the LGANT Convention we held the inaugural LGANT Circular Economy Awards "Communication and Education: Empowering the

Community". Six local government councils nominated works they had been conducting in their communities to achieve outstanding resource recovery results. The winner was East Arnhem Regional Council who managed to increase waste diversion from 484.49 tonnes to 798.98 tonnes in 2023 alone.

The LGANT Secretariat sought approval from the LGANT Board to use Financial Assistance (FA) Grant funding to contribute to the completion of the sealing of the Telstra Hill Jump up on the Robinson River Road (Project) in the Roper Gulf Regional Council area. Other funding was gained through the Local Roads and Community Infrastructure Grants and Federal Road Safety Black Spot Program. The project is complete, and we are very proud to have invested in such a needful regional and remote road project.

Putting on the April Conference and the November Convention are made a whole lot easier thanks to our corporate partners and I thank them; JLT Public Sector, Commonwealth Bank, LG Solutions, Regional Development Australia NT, Mead Perry Group, The BelRose Group, Disaster Management Australia, HostPlus, Workzone Territory, Rebus Restrooms, Orbviz, BRM Advisory and Response Employment Training.

Thank you to the President and the Board for their incredible support and to my colleagues, the staff at LGANT, Angela Barker (Executive Assistant), Mary Watson (Director Public Affairs), Nauman Zaland (Manager Roads and Infrastructure), Rachel Pritchard (Manager Corporate Services), Meredith Newall (Circular Economy Program Officer), and Sindy Chea (Marketing & Communications Officer). Also thank you to Jocelyn Cull, our Governance Consultant.

Our 2021-2024 Strategic Plan will be reviewed in February, and I am very much looking forward to working with the Board to set the strategy for LGANT for the betterment of our member councils for the next three years.

#### **SP1: Aboriginal Outcomes**

Assist Aboriginal people to have a greater voice to achieve better social, cultural, and economic outcomes.

#### Activities for SP1 2023-2024 include:

- Continue to implement the LGANT Reconciliation Action
  Plan
- Finalise and implement the Closing the Gap Implementation Plan 2 in partnership with other signatories.
- Advocate for local government interests in Aboriginal affairs policy and program development, legislative reform, and funding opportunities including, but not limited to, the Local Decision-Making policy review, Treaty and Closing the Gap.

#### SP2: Finance, Governance and Workforce

Strengthen financial sustainability and governance, and developing the workforce.

#### Activities for SP2 2023-2024 include:

- Partner with an external provider to supply NT local government appropriate training options for LGANT member councils.
- Deliver training on the Code of Conduct Panel protocols for Panel members.
- Provide Mediation Advice and a Mediation Service.
- Source external funding for new positions (Economic Development Coordinator, Emergency Management Coordinator, Aboriginal Affairs Coordinator, Road Safety Coordinator) and existing positions (Director Public Affairs and Senior Governance Advisor) to service our members.
- Review Rates Officers Manual with CouncilBiz.
- Implement the Local Government Cost Index recommendations from the KPMG report.
- Continuation of legislative interpretation and general governance advice.
- · Review LGANT meeting procedures and protocols.
- · Implement expression of interest campaign for:
  - · Local government as an employer of choice
  - · Training provider
- · Develop a new Strategic Plan (e.g., 2024-2029).
- · Renew WALGA IR/HR arrangements.

 Advocate for the financial sustainability of councils in policy and program development and legislative reform.

#### **SP3: Infrastructure**

Maintain and construct over 2,000kms of regional and remote roads and support delivery, and maintenance of other infrastructure.

#### Activities for SP3 2023-2024 include:

- · Maintain over 2,000kms of regional and remote roads.
- Develop a locum project management service for member councils.
- Advocate local government interests in infrastructure related policy and program development, legislative reform and funding opportunities including, but not limited to, improved telecommunications, better planning outcomes, and prioritisation of council projects.
- Work with member councils to ensure active participation in reviewing the NT Infrastructure Plan and Pipeline and in advocating for the prioritisation of local government infrastructure projects.
- Work with Tyre Stewardship Association in the delivery of Crumb Rubber Projects in local roads in the NT.

## SP4: Climate, Circular Economy & Environment

Adapt to the effects of climate change, manage waste and preserve the natural environment.

#### Activities for SP4 2023-2024 include:

- Implement the Local Government Circular Economy Plan including delivery of the 2024 Circular Economy Symposium.
- Work with waste and recycling industry and national organisations such as Tyre Stewardship Australia to investigate solutions for resource recovery in the NT especially for remote communities.
- Advocate for local government interests in the circular economy, emergency management and climate change policy and program development, legislative reform and funding opportunities including full membership of the Territory Emergency Management Council and funding for new emergency evacuation centres.

#### **SP5: Profile and Reputation**

Build the profile and reputation of the local government sector.

#### Activities for SP5 2023-2024 include:

- · Invite the City of Palmerston to re-join LGANT.
- Deliver the November 2023 Convention and April 2024 Conference.
- Deliver Northern Australia Local Government Summit.
- Hold roundtables with Chief Minister and Cabinet at November 2023 Convention and April 2024 Conference.
- Develop and implement LGANT Marketing and Communications Plan including finalising the new website.
- Strengthen and continue to implement the LGANT Advocacy Plan including pre-budget submissions.
- · Review the LGANT Policy Statements.
- Review LGANT external committee policy and representation.
- Participate in the Facing North 2023 and National General Assembly 2024 in Canberra.
- Implement the Local Government 2030 Strategy Guiding Principles (partnership with NT Government).
- Continue to support LGANT representatives on the ALGA Board.
- · Grow corporate partnerships.
- Start planning for the 2025 local government elections.
- Continue to implement the 2021 and 2022 Member Engagement Survey Project Report recommendations.
- Sponsor the Local Government Professionals Executive Management Challenge.
- · Undertake tour of municipal, regional and shire councils.
- Meet with other peak bodies, industry associations and land councils to discuss common issues and potential joint advocacy efforts.

## OUR 2022-2023 BOARD MEMBERS



The Hon. Kon Vatskalis President City of Darwin

Kon was born 4 April 1957 on the Greek island of Cephalonia and spent most of his life in Greece in Athens.

After living in Athens for a short time Kon immigrated to Australia in January 1983.

In Perth Kon continued his studies in public health, achieving a bachelor's degree in environmental health in 1986 from WAIT and a Graduate Diploma in Environmental Science from Murdoch University in 1989.

Kon came to Darwin in 1993, where he worked with the Department of Health before joining the Indigenous Health Service, Danila Dilba.

During that time, he completed a Graduate Certificate in Public Service Management through Flinders University.

In 2001 Kon was elected to the NT Legislative Assembly as the Member for Casuarina and he was immediately elevated to Minister.

He served as a Minster from 2001-12 in the Territory Labour Government, in a variety of portfolios including Health, Mining and Primary Industries, Tourism, Sport, Infrastructure and Planning and Children and Families. He resigned from the NT Legislative Assembly in 2014 and in 2015 started work for the Leukaemia Foundation.

In 2014 he was awarded the title "Honourable" for life from HM the Queen for his services to politics in the NT. In 2017 Kon was elected Lord Mayor of Darwin.



Mayor Matt Paterson Vice-president - Municipals Alice Springs Town Council

Alice Springs Town Council Mayor Matt Paterson was elected to the role in 2021 as a 30-year-old, making him the youngest Mayor in Alice Springs history. Qualified as an electrician, Mayor Paterson is a Member of the Australian Institute of Company Directors, Vice President of LGANT and sits on the board of Tourism Central Australia, Chamber of Commerce and Regional Capitals Australia. Mayor Paterson has an extensive history of working in various communities in Central Australia which has given him an intimate knowledge of the community.

Driven to continually improve the liveability of Alice Springs, Mayor Paterson is focused on delivering better infrastructure for Alice Springs families. He served as a Councillor previous to being elected Mayor and is passionate about providing opportunities for all residents in Alice Springs. Being a father to two young children, Mayor Paterson is focused on delivering better infrastructure for families in Alice Springs and making the community a better place for generations to come.

A decorated sportsperson, Mayor Paterson has represented Alice Springs and the Northern Territory on the cricket field and has also dedicated time off the field to growing sport in the community.

He has served as a Cricket Australia Community Ambassador, committee member of the Alice Springs Turf Club and a long-time president of his local cricket club. Mayor Paterson is also heavily involved in the community outside of sport, putting a great deal of effort into connecting meaningfully with community members from all walks of life.



Councillor Peter Clee Vice-president - Regionals and Shires Wagait Shire Council

Peter Clee has served as a member in local government as a councillor and as President and Vice President for over 22 years. During Peter's time on council, he served on several committees and groups including the Emergency Management Committee, NT Emergency Committee, and the local bush fire brigade.

He has previously represented council on the local government association executive committee and the local government disciplinary committee. He was a member and chair of Top End Shire Steering Committee at the time of the 2007 local government reforms.

Peter has worked in Banking, Law and is currently working in Information Technology which has taken him to all parts of the Northern Territory. He has also been involved in several NT remote and regional business ventures.



**Deputy Mayor Georgina Macleod**Board Member - Regionals and Shires
Victoria Daly Regional Council

Georgina has served Victoria Daly Regional Council as the Daguragu Ward member having been first elected in 2009.

Having grown up on a remote cattle Station and being educated through Katherine School of the Air (Primary School) and Secondary education obtained attending Boarding School in Adelaide, Georgina has a comprehensive understanding of the challenges communities face living remotely.

Georgina is driven to see remote communities have the same community facilities as urban centres and is driven to improve the living environment, and economic opportunities.

Currently serving as Community Housing Officer, and member of the Local Authority, Georgina has also served as a Justice of The Peace for over 25 years.

Georgina's previous experiences range from owning and operating a pastoral property and meatworks, educating her children through Katherine School of the Air, managing a remote community store, and working with Corrections.

Councillor James Woods has served his community for eight years as the longest serving chairperson for the Maningrida Local Authority. He was born in Katherine in the Northern Territory and was part of the Stolen Generation that the Department of Aboriginal Affairs moved from Katherine to the Retta Dixon Home located along Bagot Road in Darwin.

He did his initial schooling in Darwin before moving to Queensland where he completed his high school education at Warwick Boarding School. While in high school, Councillor Woods worked as a pumpkin picker in farms in Tully Queensland over the school holidays. After high school, Councillor Woods went on to university in Toowoomba, Queensland where he earned a Diploma in Early Childhood Education. He then went on to complete his BTEC while living in Queensland and the Northern Territory.

Councillor Woods moved to Maningrida with the local band "Letter Stick Band" who later became his in-laws when he married into the family who are from Blyth River. He has lived in Maningrida for 27 years and is blessed with six children and eight grandchildren.

In Maningrida, he has worked for the Council, Maningrida College, Bawinanga Aboriginal Corporation (BAC) and currently Mala'la Health Service Aboriginal Corporation. In addition to this, Councillor Woods is a member of the Defence Force (a position that he has held for 18 years) and is the Deputy Unit Officer for Emergency Services in Maningrida and is the chairperson for the Maningrida AFL Committee. He is passionate about supporting communities and advocating for essential services to be improved in remote communities. Councillor Woods is always available to assist in any way that he can.



Councillor Cyril Tasman
Board Member - Regionals and Shires
Central Desert Regional Council

Councillor (Cr) Cyril Tasman, also known as Cyril "Lamun" Tasman, is from Lajamanu Community.

Cr Tasman went to boarding college for five years at Kormilda College from 1991 to 1995 and completed year 12.

His first job was in the Lajamanu Arts Centre from 1996 to 1997. He went on to Darwin to study at Charles Darwin University from 1998 to 2000, after which he started his second job as a police officer (ACPO) from 2002 to 2006 with the NT Police in Lajamanu.

In late 2008 he joined the Australian Government National Indigenous Australians Agency (NIAA) as an Indigenous Engagement Officer or Advisor and has been in the position ever since.

Cr Tasman has always been a strong voice and an advocate for his community, advocating for access to services, housing, jobs for the youth, and recreational activities such as sports. This passion grew and in 2021, Cr Tasman stood in the local government elections where he was successful in being appointed as a Councillor for the Northern Tanami Ward in the Central Desert Region.

Cr Tasman has a vast knowledge and awareness of remote community challenges and working experience in various roles at a community level, giving him a unique view of the local government sector. He believes this will enable him to contribute to the LGANT Executive as an experienced voice for remote communities and be able to share ideas and take back learnings from peer members to his community and the Central Desert region as a whole.

In the past 4 years Peter has represented the City of Darwin on the Tourism Top End Board of Management. He is a current member of the Development Consent Authority for Darwin. Peter is a registered Aboriginal Health Practitioner and was the Chair of the NT Aboriginal Health Worker (AHW) Registration Board and the National Aboriginal and Torres Strait Islander Health Practitioner (ATSIHP) Board of Australia for 16 years.

He was also the Executive Director of Aboriginal Workforce and Cultural Engagement for Top End Health Services, as well as a Member of the LGANT RAP Committee and the Constitution Committee.

- · Distributed disability permits to councils.
- Facilitated an arrangement with DriveAbout to deliver fee-for-service council employee driver inductions to mitigate against harm and risk.
- Provide HR (Human Resources) and IR (Industrial Relations) services to member councils through a service level agreement with WALGA.
- Finalised a Waste Management Strategy for Tiwi Islands Regional Council.



## LGANT ROADS

#### Financial Assistance (FA) Grants

LGANT project managed over 2,019 kilometres of road works in the Barkly, Central Desert, East Arnhem, MacDonnell, Roper Gulf, and Victoria Daly regional council areas. These works were completed with a Federal Assistance Grant of \$1,587,181 via the NT Commonwealth Grants Commission.

LGANT continued a program of erecting road signs using the Central Australian Remote Community Traffic Management Manual developed in collaboration with member Councils, with the technical assistance of the Australian Road Research Board.

#### **Roads to Recovery**

The roads shown in Table 5 have been commenced or completed in 2022 - 2023.

#### **Local Roads and Community Infrastructure**

In collaboration with ALGA, LGANT secured an extension of the Local Road and Community Infrastructure Grant (LRCI) which is a COVID-19 response stimulus initiative. The NT allocations are \$11,583,305 (2021 - 2022 Financial Year) and \$15,937,506 (2022 - 2023 Financial Year).

Pakulki Road Barkly Region has been identified as a potential for a demonstration site to use crumb rubber sealing project under LCRI phase 4 A and B.

#### **WALGA Services**

Membership of LGANT includes access to Human Resources (HR) and Industrial Relations (IR) advice provided under contract by the Western Australian Local Government Association (WALGA).

## WALGA Employee Relations (ER) provides the following services to LGANT members:

- Advice on enterprise bargaining including a compliance review of agreements, review of enterprise agreement application forms and assistance with drafting FWC undertakings and submissions when lodging an enterprise agreement for approval with the FWC.
- Email alerts (ER Alerts) on general advice, legislative updates, and developments in case law.
- Live webinars on topical issues and a collection of recorded webinars which can be viewed on demand on the WALGA website.
- Advocacy and policy work on behalf of the local government sector. For example, this includes the preparation of submissions on proposed amendments to the Local Government Industry Award 2020 and other employment legislation impacting on local governments.
- Opportunity to participate in the annual Salary and Workforce Survey on remuneration and conditions of employment for an additional fee.

WALGA ER also offers consultancy services (subject to capacity and a fee for service) in relation to enterprise agreement negotiations, in-depth policy review, position description classifications and custom/onsite workshops (i.e. position description classification workshop, policy and procedure training and bargaining workshops).

#### **HR/IR** training

LGANT Members can undertake a number of training courses for officers delivered by the WALGA ER team, including a unique sector specific course on Understanding and Applying the Local Government Industry Award 2020. Training can be delivered remotely or onsite. WALGA can also develop bespoke HR/IR training workshops for councils.



#### **ALGA Services**

LGANT, along with other state Local Government Associations, make up the membership of the Australian Local Government Association (ALGA). ALGA is the national voice of local government, representing 537 councils across the country.

ALGA provides a range of services to state and territory member associations and, through them, local councils throughout Australia. These services include:

- representing local government on national bodies and ministerial councils, including representation by their president on the National Federation Reform Council
- policy development to provide a local government perspective on national affairs, as well as providing submissions to government and parliamentary inquiries
- raising the profile and concerns of local government at the national level by lobbying the Australian Government and Parliament on specific issues and running campaigns to secure agreed policy objectives
- providing information on national issues, policies and trends affecting local government, and
- providing forums for local government to guide the development of national local government policies.

#### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

#### 1 STATEMENT OF ACCOUNTING POLICIES

#### a) Structure

The Local Government Association of the Northern Territory ("LGANT Association") is the peak body representing the local government sector in the Norther Territory (NT). It represents 16 of the 17 local government councils. The membership consisted of four municipals, three shires, nine regional councils, and one associate member (Nhulunbuy Corporation). LGANT was formed in 1992 and under the jurisdiction of the previous NT Local Government Act 2008.

Under the new Local Government Act 2019, which became effective from 1 July 2021, LGANT Association will no longer be included in this new Local Government Act. In view of this, the Association will have at least 18 months from 1 July 2021 to transition from being an Association under the previous Local Government Act to an incorporated company limited by guarantee in accordance with Corporations Act 2001. The change in incorporation will be finalised within 18 months from 1 July 2021. It is envisaged that all assets and liabilities will be transferred from the Association to the new Company once it is established.

LGANT Ltd ("LGANT Limited") is a company limited by guarantee under the Corporations Act 2001 and was registered with Australian Securities and Investments Commission on 30 September 2022. Similar to LGANT Association, LGANT Limited supports the local government sectors and its member councils by advocating in behalf of its member councils to the Northern Territory and Australian Government, delivering effective leadership and advice on policy issues and developments, delivering improved services and specialised advice and undertaking infrastructure project management.

As LGANT Association ceased its legal existence under the new Local Government Act 2019, LGANT Association is required to transfer its business operations and net assets and liabilities to LGANT Limited effective from 1 January 2023. Whilst a portion of the LGANT Association business operations and net assets and liabilities were transferred to LGANT Limited on that date, the remaining net assets and liabilities and business operations will be transferred in the 2023/24 financial year.

As at 1 January 2023, LGANT Association transferred part of its operations and net assets of \$4,503,766 to LGANT Limited. These assets and liabilities consisted of the following:

The cash was received by LGANT Limited from LGANT Association between 14 December 2022 to 23 June 2023 representing a portion of the unexpended grant income received by LGANT Association in the previous year, cash reserves for employee provision and current year grant income collected and banked initially in LGANT Association's bank account. The net assets received by LGANT Limited as at and for the year ended 30 June 2023 amounted to \$4.50 million and is recognised as contributed equity in LGANT Limited's statement of financial position.

The net assets transferred by LGANT Association to LGANT Limited was deducted against its accumulated surplus account as at and for the year ended 30 June 2023.

On 29 June 2023, LGANT Association received \$1.98 million from the NT Government for the Commonwealth Government funded Financial Assistance Grant 2023/24 (FAG). The FAG amount was intended for LGANT Limited but was debited in LGANT Association's bank account. Accordingly, both LGANT Association and LGANT Limited recognised advances to / from the relevant accounts in the respective Statements of Financial Position as at 30 June 2023. The FAG monies received in advance was recognised as Uneamed grant income liabilities in LGANT Limited's Statement of Financial Position as at that date.

#### b) Basis of Accounting

This compiled special purpose financial report has been prepared in accordance with Australian Accounting Standards for distribution to the members of LGANT Association and Board of LGANT Limited. This special purpose financial report included the compiled combined statement of financial position, compiled combined statement of comprehensive income and compiled combined statement of cash flows and accompanying notes to financial statements of LGANT Association and LGANT Limited as at and for the period ended

The compiled special purpose financial report has been prepared on the basis that there are unlikely to exist users of these financial statements who are not in a position to require the preparation of reports tailored to their information needs.

Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

#### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

The financial statements, except for the cash flow information, have been prepared on an accrual basis. This was also based on historical costs, except for Office Building which are carried at revalued amount. Historical cost is generally based on the fair values of the consideration given in exchange for goods and services.

The amounts presented in the financial statements have been rounded to the nearest dollar.

#### c) Economic Dependence

Both LGANT Association and LGANT Limited is reliant upon the receipt of government grants and members' subscriptions to operate as a going concern.

#### d) Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the entity and the revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recognised:

#### Grants

Grant revenue is recognised in profit or loss when the entity satisfies performance obligations stated within the funding agreements.

If conditions are attached to the grant which must be satisfied before the entity is eligible to receive the contribution, the grant will be recognised in the statement of financial position as a liability until those conditions are satisfied.

Operating grants received in advance are recognised as income in the statement of comprehensive income.

Where LGANT Association or LGANT Limited receives contributions of assets from the government and other parties for zero or a nominal value, these assets are recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in profit or loss.

#### Interest revenue

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument

#### Other income

Revenue from the rendering of a service is recognised upon the delivery of the service to the customer.

All revenue is stated net of the amount of goods and services tax.

#### e) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value as indicated, less, where applicable, accumulated depreciation and any impairment losses.

#### Office Buildings

Office buildings is shown at their fair value based on periodic valuations by external independent valuers, less subsequent depreciation for buildings.

In periods when the property is not subject to an independent valuation, the directors conduct directors' valuations to ensure the carrying amount for the property is not materially different to the fair value.

Increases in the carrying amount arising on revaluation of property are recognised in other comprehensive income and accumulated in the revaluation surplus in equity. Revaluation decreases that offset previous increases of the same class of assets shall be recognised in other comprehensive income under the heading of revaluation surplus. All other decreases are recognised in profit or loss.

Any accumulated depreciation at the date of the revaluation is eliminated against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

#### Plant & Equipment

Plant and equipment, which included motor vehicles and furniture, fittings and equipment, are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset.

#### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

#### Depreciation

The depreciable amount of all fixed assets is depreciated on a straight line basis over the asset's useful life to the entity commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss in the period in which they arise. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

#### f) Cash and Cash Equivalents

Cash and Cash Equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the statement of financial position.

#### g) Employee Benefits

#### Short-term employee benefits

Provision is made for the entity's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries, annual leave and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

LGANT Association or LGANT Limited 's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as part of current liabilities in the statement of financial position.

#### Other long-term employee benefits

The entity classifies employees' long service leave and annual leave entitlements as other long-term employee benefits as they are not expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on high quality corporate bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur.

The Association's obligations for long-term employee benefits are presented as non-current liabilities in its statement of financial position, except where the entity does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current liabilities.

#### h) Taxation

Both LGANT Association and LGANT Limited is an exempt body under the Income Tax Assessment Act.

#### Trade and Other Receivables

Receivables are carried at nominal values less any allowance for doubtful debts. An allowance for doubtful debts is recognised (and reassessed annually) when collection is no longer probable.

Receivables are unsecured, and do not bear interest

#### j) Provisions

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

#### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

#### k) Trade and Other Payables

Creditors are amounts due to external parties for the supply of goods and services to the end of the financial year and remain unpaid. Creditors are normally paid within 30 days after receipt of the invoice. No interest is payable on these amounts.

#### I) Superannuation

LGANT Association and LGANT Limited, as applicable, makes employer superannuation contributions to the superannuation funds nominated by its employees. Contributions are based on a fixed percentage of ordinary time earnings in accordance with the superannuation guarantee legislation.

The contribution made to the Statewide Superannuation Fund was at the rate of 11.50% for contributory LGANT Association and LGANT Limited employees.

The contribution made to employee nominated superannuation funds was at the rate of 11.50% for contributory LGANT Association and LGANT Limited employees.

#### m) Borrowings

#### Vehicles:

The Association has a loan with the National Australia Bank for a new vehicle purchased in the 2020-2021 financial year which was paid-off during 2022-2023 financial year. See note 6 for commitment details.

#### Office Building:

The Association has a Commercial Loan with the National Australia Bank for the purchase of this asset. See note 6 for commitment details.

#### n) Leases

Lease payments for short-term leases and leases for which the underlying asset is of low value are recognised as expenses on a straight-line basis over the lease term.

For all other leases the entity recognises a right-to-use asset that is measured at cost and a lease liability measured at the present value of the lease payments not paid. The lease payments are discounted using the interest rate implicit in the lease.

#### o) Financial Instruments

A financial asset is recognised at amortised cost if the objective is to hold assets to collect contractual cash flows. All other financial assets are classified and measured at fair value through profit or loss.

Financial liabilities are measured at amortised cost calculated using the effective interest method.

#### p) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.
